# AGENDA ITEMS

## Welcome/Purpose

- The primary function of the POE AG is to help the MAC create, implement, and review
  provider education strategies and efforts. The POE AG provides input and feedback on
  training topics, provider education materials, and dates and locations of provider education
  workshops and events. The group also identifies salient provider education issues and
  recommends effective ways to disseminate information to all appropriate providers and
  their staff.
- Nykesha recapped the recommendations/progress received during the March meetings.

## **POE AG Recommendations**

## Medical Review (MR) Update

AG members suggested information be shared concerning MR Reviews and Top Denials.

- Medical Record Reviews: CGS continues to keep our MR activity log updated with current review topics and criteria. We continue to review Home Health (2-6 visits, diagnoses: I11.0, Z46.6, J44.1, I10, J44.9, G20, I25.10, N39.0, J18.9, or I87.2) and Hospice Services (GIP > or 7 days and LOS 730+ days excluding diagnosis codes between C00 and D49.9). CMS has approved Postpayment service specific review of claims with dates of service after March 1, 2020. CGS has started sending ADRs for DOS after 3/1/2020. We are reviewing claims in all states within our jurisdiction. The published activity, which includes details on what we are reviewing can be used as criteria for internal data analysis to assess risk for selection of claims for review.
- Top Denials: CGS MR continues to publish quarterly status updates on denial trends with educational material. The latest updates on Postpayment reviews can be found at, <u>https://www.cgsmedicare.com/hhh/medreview/pr\_review.html</u>. Please note, we are not currently conducting any probes or targeted review activity. We are only conducting Postpayment service specific review activity.

POE AG members suggested after reviewing claims with dates of service after March 1, 2020, that CGS conduct an educational offering surrounding concerns found during recent reviews.

## Medicare Secondary Payer (MSP) Education

One group member asked to discuss MSP concerns. Nykesha reminded the group of the MSP web page, <u>https://www.cgsmedicare.com/hhh/education/materials/msp.html</u>, that includes a myriad of resources and advised there will be a MSP webinar held in August. She asked for specific topics to be included in this event. No comments were received.





#### Value-Based Insurance Design (VBID) Model Check-In

The group was asked if they are hearing VBID concerns as one member noted billing/claim opportunities for efficiencies and that provider burden is an issue. Judi (NHPCO) advised they are also interested in hearing about provider burden issues. Nykesha stated it has been fairly quiet from a CGS standpoint. Theresa (NAHC) followed with since there are only a small number of plans, we may not be hearing a lot. Information will be shared with CMS during the ongoing analysis discussion meetings.

#### Joint Replacement F2F/Surgicenter/Same Day Setting

A question was posed by a group member regarding acceptable face-to-face encounter notes for joint replacement surgery. Many joint replacement surgeries are performed in same day surgery centers. This question was forwarded to CGS's MR educator who indicated that a discharge summary or even a pre-op note can serve as the face-to-face encounter given that the reason for the admission is clearly documented and it meets all the requirements of the FTF encounter (timeframe, content, etc.). It must also be documented by the certifying practitioner. I would suggest that the op note also be submitted with that documentation to support skilled need. An additional question was asked regarding potential compliance issues with free-standing surgery centers referencing the issues with using notes from free-standing emergency departments. We will follow-up with MR and email the answer to that question.

#### **HETS/CWF What's New**

EDI has completed gathering information concerning users and has begun sending out notifications via email. Access to Common Working File (CWF) eligibility transactions HIQA, HIQH, ELGA and ELGH is being removed August 31, 2021. Submitters that have both HETS and CWF based eligibility access should use the Health Insurance Portability and Accountability Act) Eligibility System (HETS) exclusively on and after August 31, 2021. Submitters may also access beneficiary eligibility via myCGS or DDE. #### **Current Tasks**

#### Video Review – Other Video Topics

The group watched a video developed by CGS regarding 2021 RAP changes and was asked for feedback. The group loved the video and the visuals. When asked if they would prefer a PowerPoint instead of the visuals used, the majority said the current visuals are best. They also liked the calendar example in the video as well as the length. Group members recommended videos ranging from two to five minutes max, "short and to the point". When asked for additional topics, documentation tips and topics stemming from final rules were recommended. Nykesha advised a Notice of Admission (NOA) video is under development and will be shared with the group for feedback once it's ready.

#### **Electronic Funds Transfer (EFT) Scam Alert**

Cari informed the group of a scam that initially impacted Medicaid administrators and is now impacting MACs. There have been entities contacting the MACs to have EFT information changed to basically route money from the good guys to the bad guys. Contact has both been through Customer Service and through written channels. Several inquiries have had numerous follow-ups and have been very persistent and at times forceful. However, they haven't been legit. Entities have even called call centers to get the name of the Authorized Authority for a company. CMS is aware and will forward additional information.

## **CGS Data Analysis**

The group reviewed the top Claim Submission Errors (CSEs), and Medical Review denials.

- Regarding MR denials, error noticed on hospice denial concerning General Inpatient Care (GIP/denial code 5PM02) and payment reverting back to routine payment rate (respite was listed). This has been corrected.
