- » Following modifiers will be effective April 1, 2023
  - JK: Drug 1-month supply or less = One (1) month supply or less of drug or biological
  - JL: Drug 3-month supply = Three (3) month supply of drug or biological
- » Before July 2023
  - For "from date of service" in May or June 2023, bill a 1-month supply of insulin with the JK modifier.
- » Starting July 2023
  - For "from date of service" in July and later, bill a 1-month supply of insulin with the JK modifier, or a 3-month supply of insulin with the JL modifier.
- · Hospice & GW Modifier
  - Hospice and GW Modifier Prepayment Reviews <a href="https://www.cgsmedicare.com/jb/pubs/news/2023/04/cope137079.html">https://www.cgsmedicare.com/jb/pubs/news/2023/04/cope137079.html</a>
    - » CGS Medical Review has initiated pre-payment review of claims for which the GW modifier is appended.
      - Reviewed the hospice benefit administered under Medicare Part A. Most items are bundled into the hospice per diem benefit.
      - Use of the GW modifier means that the item or service is not related to hospice patient's terminal illness.
      - Tips for supplier who may have claims selected for GW modifier review.
    - » Hospice Election Statement Addendum
      - CGS will be requesting the addendum for pre-payment reviews.
- Education Email Notifications
  - Educational Opportunities
    - » Implemented in April to include 2-week notification of educational events.
      - Notifications will go out each Monday afternoon with a list of the upcoming webinars, teleconferences, and registration links.

### III. myCGS Web Portal Updates

Kathryn reviewed the updates and improvements to the myCGS web portal:

- Version 7.3.10 (New Features & Improvements)
  - Ordering/Referring Physician Screen
    - » Search Results
      - The provider has a valid enrollment record in PECOS.
      - The provider has a deactivated record in PECOS.

- myCGS will display the provider's deactivation date, as well as the capped-rental deactivation date (if applicable)
- The provider has no enrollment record in PECOS.
- Additional Claim Detail Screen
  - » Updated to allow for easier viewing.
- » Address an issue where the screen was not displaying in its entirety in some web browsers.
- Prior Authorization Status Screen
  - » Updated to allow for viewing the status of PA accessories if related base is affirmed.
- Version 7.3.11 (New Features & Improvements)
  - Set a default NPI/PTAN
    - » Users will be able to set a default NPI/PTAN that will remain selected and display each time they log into the portal.
  - Eligibility Screen
    - » Will be updated to display all MAP information with an effective date that falls on or within a 16-month span.
      - 1 year before through 4 months after the date of service entered.
  - User Permissions Screen
    - » Will be updated to include a "Select ALL" option for Designated Approvers (DAs).
      - This feature will be in addition to the existing individual "User Permissions" table.
      - Will allow DAs to set user permissions for a group of End Users.

### IV. Website Updates

Kathryn advised the group Rachel Sinclair has accepted a position with Business Excellence with CGS. Kathryn provided a live demonstration of the website updates.

- · Left-Hand Navigation Menu
  - Update "Appeals" tab
    - Renamed to "Redeterminations"
      - Reduced sub-tabs from 10 to 2
      - Reduced the amount of text (word count) by 80%

Andrea Hanson greatly appreciates the new tabs and the new look.
