## I. Welcome and Introductions

Denise welcomed the group and made introductions.

### II. What's New

#### **CR Modifier/COVID-19 Education**

- There have been no recent updates as to when the nonenforcement will end, and there is no additional information regarding continued coverage after the end of the public health emergency (PHE). Denise reminded all to append the CR modifier and COVID-19 in the narrative field if the claim is affected by the PHE.
- Denise also mentioned that we have no direction from CMS as to what will occur once the PHE ends.

#### **Oxygen Update**

- Denise reviewed the summary of changes regarding National Coverage Determination (NCD) 240.2
- · The following was removed from NCD
  - Rebuttable presumption that those individuals who do not experience hypoxemia/severe lung disease have no need for home oxygen (Group III).
  - Language referring to the chronic stable state;
  - Requirement for the prior use of alternative treatment;
- The NCD update will now allow home oxygen coverage for beneficiaries with acute, short term need for home oxygen therapy
- Elimination of certificate of medical necessity (CMN) January 1, 2023

#### **Continuous Glucose Monitors (CGMs)**

Kathryn reviewed the following categories of the CGM device:

#### Adjunctive

- Non-therapeutic
- Used to verify glucose levels or trends displayed on a CGM with a blood glucose monitor (BGM)
- Classified as Durable Medical Equipment (DME) on February 28, 2022
- Adjunctive CGMs incorporated into an insulin pump are the only devices in the United States meeting DME benefit
- Currently no stand-alone adjunctive CGMs on the US market meet the definition of DME
- Non-Adjunctive
  - Therapeutic
  - Used to make treatment decisions without a stand-alone BGM
  - Classified as DME in 2017
  - Glucose monitors used as a *replacement* for finger-stick blood glucose testing treatment decisions

Kathryn also provided education on the coding for the following CGM supply allowances:

- Adjunctive CGM devices prior to 04/01/22 bill HCPCS E1399
- Adjunctive CGM devices after 04/01/22 bill HCPCS E2102
- Insulin pump with adjunctive CGM capability prior to 04/01/22 bill E0784 and E1399
- Insulin pump with adjunctive CGM capability on 04/01/22 and after – bill E0784 and E2102
- CGM supplies used with adjunctive CGM prior to 04/01/022 bill A9999
- CGM supplies used with adjunctive CGM 04/01/22 and after – bill A4238

# III. myCGS Updates

Tracy Sessoms provided the following updates to the myCGS portal:

- Same/Similar tab in testing phase
  - Adds the ability to check same/similar on CGS website for those that do not bill JB/JC
- Requires only one verification for JB/JC

Tracy explained the following items are on the enhancement list for myCGS:

- Select "all" column in User Management for new features for all NPIs and PTANS
  - This feature lets users select a default NPI so that they do not need to keep updating it when using the portal

• Ability to upload documentation for CGS Connect through the portal instead of faxing
