### I. Roll Call & Purpose

Judie welcomed the group, then reviewed the purpose of the advisory group:

- The primary function of the Orthotics and Prosthetics (O&P)
  Provider Outreach and Education (POE) Advisory Group is
  to assist CGS in the creation, implementation, and review of
  provider education strategies and efforts.
- The advisory group provides input and feedback on training topics, educational materials, and dates and locations of provider education workshops and events.
- The group also identifies relevant provider educational issues and provides recommendations of how to effectively distribute the information to all appropriate suppliers and their staff.

Judie reminded the group of the importance of completing the surveys and offered the three new members the opportunity to introduce themselves, which they did.

#### II. Updates and Changes

Judie provided information about the temporary gap in competitive bidding that starts January 1, 2024. During the temporary gap period, Medicare-enrolled DMEPOS suppliers may furnish DMEPOS items and services to patients. CMS will update the 2024 fee schedules.

She then reviewed the transition from paper checks to Electronic Funds Transfer (EFT). EFT forms and inquires will now be handled by the NPE contractors.

Updates on suggestions from the last meeting:

Suggestion: Add additional orthoses codes to CGS Connect®/

Prior Authorization

Response: Suggestion has been sent to MR and CMS

Suggestion: Address same/similar with upper limb orthoses

**Response:** When submitting a claim for a same or similar orthoses, include a narrative as to how the new item is different or treats a new/different condition than the previous item.

#### **Educational Feedback & Online Tools**

Judie asked if anyone attended webinars, workshops, association meetings, councils, or the Ask-the-Contractor Teleconferences (ACTs).

- Members stated their staff attends webinars and uses the information to train all members of the staff and the webinars are beneficial.
