- The group also identifies relevant provider educational issues and provides recommendations of how to effectively distribute the information to all appropriate suppliers and their staff.

Judie provided information regarding the prior authorization of certain lower limb orthoses HCPCS codes (L0648, L0650, L1832, L1833, and L1851) and that phase 3 has been implemented on October 10, 2022, in all remaining states and territories.

Suggestion: Market the CGS Medicare App, more as it is an excellent resource.

**Response:** CGS made improvements to the app and began marketing.

**Suggestion:** Tailor the electronic mailing list to supplier type or policies.

**Response:** CGS will not implement this suggestion at this time but will be considered for the future.

**Suggestion:** Host a collaborative A/B and DME MAC webinar on orthoses again.

**Response:** POE will host an A/B/DME collaborative webinar in 2023.

**Suggestion:** Reconsider how orthotist and prosthetist documentation is considered for medical records.

**Suggestion:** POE sent this suggestion to the DMDs for consideration.
