

POST REVIEW EDUCATION CALL TOOL

The purpose of the education call is to provide education, resources, and answer questions concerning claim denials as a result of CMS directed postpayment medical review. The educator's role is to present information addressing the reason for the denial and communicate insight aimed at the medical review findings. The call is not intended to serve as a verbal appeals process.
