- · Initial enrollments require the submission of the CMS 588.
- Federally-mandated requirement.
- If an enrolled supplier, currently receiving paper checks, submits a CMS 855 change request, the provider must also submit:
- CMS-588 that changes payment mechanism to EFT.
- Supplier is not required to submit a CMS-588 in conjunction with a termination or a reassignment.
- The account receiving EFT payments must exclusively bear the name of the physician/practitioner/legal business name of the person/entity enrolled with Medicare.
- Original voided check, or account information on bank letterhead is required with the CMS-588.
- The Automatic Clearinghouse (ACH) routing number must be identified on the CMS-588 and the proof of account (voided check or bank letter).
- Benefits of EFT:
 - Enrollment is free.
- Faster payment.
- Reduce risks.

- · Instructions:
 - Complete an enrollment form with the original signature of your authorized representative.
 - Attach a voided check or your account information on bank letterhead.
- You must agree to accept electronic payment.
- This federally-mandated requirement applies to established providers submitting a change of information that are not already set up for electronic payment, as well as new enrollees.
- An Electronic Funds Transfer Authorization Agreement (EFT) form (CMS-588) must be included with your application request.
- If the supplier's financial institution does not/will not participate in proposed EFT transaction, the supplier must select another financial institution.
- If supplier is not in PECOS and makes any change to EFT information, an entire CMS 855 is required.
