This takes you to the appropriate Publication and Chapter; you then review the Table of Contents for your specific topic/section number. Most chapters in the Online CMS Manual allow you to click on the specific section in the Table of Contents which takes you directly to that section in the chapter. Other chapters require that you scroll through the chapter to find the section noted in the specialty manual.
