The primary function of the Advisory Group is to assist the contractor in the creation, implementation, and review of provider education strategies and efforts. Current Tasks

Education Feedback

The meeting started with CGS asking for feedback on educational offerings attended since last meeting in 2024. Members stated that the education offered was well rounded and consistent. CGS asked members to make sure and take surveys to give feedback when attending. Members requested more case studies in education when possible and for more in-depth information Medicare Secondary Payer scenario based education.

Current Topics

Education on Removal of Eligibility Information from the IVR

On February 28th, eligibility information was removed for CGS' Interactive Voice Response Unit. CGS started doing education on this back in November of 2024. The group discussed the effectiveness of the overall education, stating it was well covered.

myCGS Violations

CGS discussed with members why some users are being revoked from myCGS due to abusive usage. It was explained if it is found that usage seems to be AI based due to transaction count, that user is revoked. Also if that user is the provider administrator of the facility/group, then all users attached to the administrator looses access.
